#### **New Business**

1. Pastoral Relations Minister Report – Micol Cottrell

Hope all had a good Christmas. Micol was able to attend online worship due even with being snowed in. One of the blessings was that the life of the community was able to be shared beyond the church walls.

The M&P Workshop on January 17 had 140+ attend. Members are catching up on learning about their work in the church. Some took this as a refresher and many were brand new to this work. The workshop was recorded and will be posted online to be available as a resource. Planning on 3 M&P trainings a year. Next one is May 2 and then September.

Micol is getting a lot of contact through email and phone. Will be constant catching up on this. Liaisons to be in place earlier in the process of search to assist communities in resourcing and encouraging. Educating, resourcing and connecting. This is the three-legged stool approach.

We are in the midst of the Tri-Regional Evaluation. Administrative staff are resourcing the evaluation team.

The Liaisons list is used by Congregational Support Commission and us. Please add to this if you notice any missing pieces. Liaisons make the connection with the search team and can refer them to the PC Supervisor. The liaison will have the contact information.

Communities of faith have wanted more autonomy. Micol is meeting with HR commission chairs before commission meetings. This is helpful for both Pat and Micol.

#### 2. Executive Report – Pat Tooley

The executive meets right after our regular monthly meeting. Mission & Discipleship Commission has been renamed the Discipleship and Justice Commission. The Covenant Commission is now known as the Congregational Support Commission and Lynne Allin is now Minister, Congregational Support.

Spring meeting is coming up on June 8 and 10, 2023. There may be a possible \$10 fee for meals.

Orphan cemeteries will now have a group of trustees: president, treasurer and executive minister. Approval has been given to Halton Presbytery Extension Council Board. Hamilton Presbytery Extension Council Board next to be approved.

#### 5. Motions Outside of Consent Docket

**MOTION** by Susan Stephen / Doug Caldwell that the Human Resources Commission of Horseshoe Falls Regional Council accept the request from St. James United Church, only 3 services while covering Ryk Brown's sabbatical from June 1 to August 31, 2023.

MOTION DEFEATED

Morar Murray-Hayes and Mike Veall abstained from the vote.

Discussion: Ryk Brown's vacation is from April 30 and continues into his sabbatical from June 1 to August 31, 2023. LLWLs have oversight with the Human Resources Commission and regional council. Candidates have oversight with the Office of Vocation. A lay-led congregation with a CDM, may provide worship, with regional council accountability.

A layperson providing worship services does not fall under any UCC oversight or accountability. The board of governors of the community of faith takes this upon themselves.

A letter will be conveyed, that as a layperson we have no policy under which to grant an extension to more than 3 worship services in a row in one location. Only occasional pulpit supply is allowed. Will include information on LLWL certification.

Next meeting: can entertain a general extension for LLWLs to cover sabbaticals.

## **6. Ministry Survey** Barb Duffin

This survey is a place we can be proactive. Having trouble getting clear lists of communities of faith that have started with a new minister in the last two years. I got different ones from consent dockets than I received from Micol. This survey will be going to all ministers,

# 7. Retired Ministers Contact Morar Murray-Hayes

ChurchHub.ca and Pension are two different areas that are separated by privacy of information. Retired ministers that want to update their contact information would need to get in touch with <a href="ministry@united-church.ca">ministry@united-church.ca</a>.

Who manages/updates the list of retirees in ChurchHub? The lists came from former presbyteries and conferences. Since 2019 they are updated by retirees themselves. Some may not have heard about ChurchHub and some may not want to go to that much trouble. Who do retirees get in touch with to make changes? They would contact <a href="ministry@united-church.ca">ministry@united-church.ca</a>. Of they can call the United Church office at 1-800-268-3781. How would we get phone numbers for those we can't find: Michelle Hogman has volunteered, may need another volunteer.

Morar started with a list of 175 retired ministers in Horseshoe Falls. 20 were incorrect email addresses. Five replied back with a 'please do not contact.' These ministers were sent an email by Morar thanking them for their service.

Of the 138 retirees with email addresses, 119 have current email address in ChurchHub. Niagara Presbytery Extension Council is looking to host a lunch.

## 8. Tri-Regional Evaluation Bill Allen

Have some questions to ask the commission members. Requesting to come back for next meeting and have some time at the beginning.

When regional council structure was formed, we wanted to review it in three years for efficiency, effectiveness, accountability and delivering on the purpose of the regional council. I am a member of Stone United Church and have been at the local United Church level. I bring a background of consulting on board governance, not-for-profits and charities. Between myself and Jenny Stephens we are meeting with commissions, communities of faith and Executives. We also need access to more complete lists covering communities of faith to send our surveys for evaluation.
