# **Conversation with Executive Minister Mark Laird Re: Property Policy**

At the Fall Regional Council, we will be discussing Property issues.

- Explaining the Regional Trust and to understand that if a congregation disbands it won't necessarily be sold.
- This could create income streams for the future.
- Will review current Property Policy.
- What does the Regional Council do with the portion of the sale of a church. Defined it should be used to support communities of faith.
- 33% to the United Church ministry(ies) of the community of faith's choosing (provided a registered charity)
  - · 2% to Archives
  - 15% to Indigenous Ministries in response to the Calls to the Church (received GC43) to support Indigenous Ministries and to upgrade Indigenous real property
  - · 10% to current year Mission and Service
  - 15% to Mission and Service Endowment Fund to provide for the future
  - 25% to the regional council to enable it to provide ongoing support and resources to communities of faith.
- How can we use those funds in new ways? Currently the funds are invested (in compliance with the Investment Policy).
- Some of these property funds are used for wages to pay staff in the Regions.
- Some funds are used to pay outstanding assessments.
- Some funds are used in Right Relations work with Indigenous Ministry events ie Five Oaks gathering.
- Break out rooms will be opened for folks at the HF RC Fall Meeting asking "What do people think a good use of property funds?".
- How can we support communities of faith with funds that can be accessible through the property fund?
- HF has a nominal amount of unrestricted reserves available for use.
- Let the Regional Representatives dream about how the funds might be used. Reference to Bare Naked Ladies song "If I had a Millionaire Dollars".
- HF RC currently has a few properties that have not been sold and won't be sold and are waiting on future development.
